Statement of Eligibility

Five Area Telephone Coop and West Plains Telecommunications award a number of scholarships to high school seniors who reside in one of the telephone exchanges served by our Companies. The scholarships are very competitive and receive careful review by our Board of Directors.

Every qualified high school senior is encouraged to return an application, either through the school administration or individually. To be considered, students must adhere to the following criteria.

High school seniors applying for the scholarship are personally responsible for submitting a completed application form with appropriate signatures and other information required. It is the student's personal obligation to assure that the application form is received by the posted deadline. Applications are due at the office of Five Area Telephone/West Plains Telecommunications in Muleshoe, TX **no later than the end of the workday on Monday, April 15 2024**. Please carefully read the additional eligibility requirements for all applicants:

1. The student must be in the immediate family or a dependent of an active Five Area/West Plains customer who is receiving landline telephone service from Five Area/West Plains. **Cellular phone service does not qualify for scholarship eligibility.**
2. The student must use the scholarship to attend an accredited vocational school, a college, or a university. Students may transfer to or from institutions without penalty as long as academic eligibility is maintained. Should the student drop out of school for any reason, the unused portion of the scholarship will be rescinded.
3. The student must have EXACTLY two (2) letters of recommendation accompanying the application form. One of the letters must be from a school official (teacher, principal, counselor) from the school where the student is attending and will graduate. The other letter may be from any other adult who may attest to the student's qualifications and abilities. Supplemental materials including additional letters, transcripts, or other attachments may cause the application to be discarded and removed from consideration.
4. The student has the responsibility to assure that the application form is complete and **is legible** with all signatures and supporting information. Completed application forms must be submitted by the posted deadline to the following address:
